

Wahl Dirty Dogs Photo Contest 2020

RULES AND REGULATIONS

A PURCHASE IS NOT NECESSARY TO ENTER THIS CONTEST

DATES OF CONTEST:

Contest opens on September 8, 2020 at 12:00 a.m. Central Standard Time (CST) and closes on November 3, 2020 at 11:59 p.m. CST (the "Contest Period"). The submission period will begin on September 8, 2020 at 12:00 a.m. CST and Contestants must submit all entries no later than 11:59 p.m. on September 30, 2020.

ELIGIBILITY:

This Contest is intended for residents of the United States of America only, and by entering you agree that this Contest will be subject to and governed by the laws of Wisconsin, excluding all conflict of law rules, and the forum for any dispute will be in Wisconsin in the City of Milwaukee. This Contest is being conducted by Hoffman York ("HY"), and excludes employees and personal associates, families, as well as those with whom they reside, of HY, directors, officers, representatives and agents of HY, and Wahl, GreaterGood.org or The Animal Rescue Site (hereinafter referred to as the "Sponsors"). All entrants and winners must be 18 years of age or older.

HOW TO ENTER:

Via the Wahl Dirty Dogs Before and After Photo Gallery ("The Gallery")

(1) Visit The Gallery located at <http://www.dirtydogsgallery.com/post-to-gallery/>

(2) Registration: Complete the official Contest online entry form (the "Entry Form") in its entirety including: first name, last name, pets' name, and contact information. You must submit a before and after photo of the same pet.

Entries will be rejected if the required fields of the entry form (labeled with *) are not fully completed and submitted during the Contest Period. Use of any automated system to enter is prohibited and will automatically result in disqualification.

There is no limit on entries during the submission period.

Sponsor and Contest Entities are not responsible for lost, late, mutilated, or incomplete Submissions. All Submissions (including all intellectual property rights embodied therein) shall become the exclusive property of the Sponsor and will not be returned. Sponsor has no obligation to acknowledge receipt of or to return any Submissions received.

By submitting an Entry Form and other required submission materials, the entrant: (i) warrants and represents that he/she has read these Official Contest Rules, is eligible to participate in the Contest and agrees to be bound thereby; (ii) warrants and represents that all of the information provided in his/her Submission materials is accurate. JUDGING:

From the close of the submission period to October 13, 2020, a panel of judges selected by Sponsors shall select ten (10) entries. Entries shall be judged on adherence to the contest's submission description and requirements.

VOTING/WINNING:

October 13 – November 3, 2020 users may vote once daily for their favorite of the top 10, selected by Sponsors. Voting officially closes at the end of the Contest Period on November 3, 2020 at 11:59PM CST. Voting will take place on the Wahl Facebook Page on the voting app accessed via the URL <http://dirtydogscontest.com>. Winners will be chosen based on votes, HY and Sponsors reserve the right to determine which votes are eligible.

GRAND PRIZE:

The shelter or rescue group must be a registered 501c3 nonprofit or municipality. No transfer or substitution of prize is allowed except at the sole discretion of Sponsor due to prize unavailability for any reason and only then for a prize of equal or greater value. There is no cash alternative offered, except at the sole discretion of Sponsor.

Each Grand Prize Winner will be responsible for any cost above the stated approximate retail value. Any difference between the stated approximate retail value and the actual value will not be awarded.

PRIZE REDEMPTION:

All eligible winners will be contacted by Sponsors at the end of the contest. The Prize will be forfeited by an eligible winner if that eligible winner cannot be contacted within forty-eight (48) hours after the Contest draw. Odds of winning a Grand Prize depend on the total number of eligible entries received during the Contest Period. None of the prizes awarded may be substituted and are not transferable.

GENERAL CONDITIONS:

If the identity of an on-line entrant is disputed, the authorized account holder of the e-mail address submitted at the time of entry will be deemed to be the entrant. The individual assigned to the e-mail address for the domain associated with the submitted e-mail address is considered the authorized account holder. A selected entrant may be required to provide proof that he/she is the authorized account holder of the e-mail address associated with the selected entry. The sole determinant of time for the purposes of receipt of a valid entry or vote in this Contest will be the Contest server machine(s).
